I/We hereby agree to care for this dog humanely (including providing adequate food, water, shelter, love and attention). The dog shall be maintained in an adequate and enclosed area or on a leash at all times. The dog is to be kept inside the house when home alone and not left unattended outside. The Dog shall not be allowed to roam at will.

I/We hereby agree that this dog will be vaccinated annually with the necessary inoculations (DHLPP or equivalent) and vaccinated against rabies, as local ordinances require. The dog must receive necessary veterinary care. It is recommended that this dog be placed on heartworm prevention. CCAS had a heartworm test performed when the animal was accepted. I understand that if this test was done more than two weeks ago a test will be required prior to the commencement of heartworm prevention.

If this dog is too young to be spayed/neutered and vaccinated, CCAS will be responsible for the first DA2PPV/C shot. CCAS will also be responsible for the spay/neuter and rabies shot at approximately 4 months of age; you will be contacted by CCAS prior to this date. You agree to call us if you have any question, concern or have not heard from us by this date. The dog must be taken to the veterinary clinic directed by CCAS for any vetting items CCAS agrees to. A copy of this adoption contract must be provided to the veterinary clinic upon admission because CCAS must be provided with the patient record proving this dog has been spayed/neutered and vaccinated. (CCAS will be happy to provide you a duplicate copy of this contract if you need one). Owner also understands they will be responsible for the second and third DA2PPV/C shots if they have not been given prior to this adoption.

I/We hereby agree this dog will not be used for illegal purposes and will NEVER be fought in any way. If this clause is broken, it is the understanding that law enforcement agencies will be notified!

I/We certify that we do not live in an area with a ban on this breed of dog.

I/We understand that the health and/or temperament of this dog is not guaranteed or warranted.

I/We agree to be solely responsible for this animal, and to indemnify and hold harmless Canines 'n Cats Adoption Station from any and all claims of liability for the conduct of this animal. The release of liability and indemnification shall apply to all known, unknown and unanticipated damages resulting from my/our foster and control of such animal.

I/We agree that CCAS has the right to make a home visit within the first 30 days of this adoption to ensure the health and safety of the dog.

I/We further agree that if I/WE ever give up ownership of this animal, it will be returned to CCAS.

BY SIGNING I/WE HEREBY ACKNOWLEDGE THAT I/WE HAVE READ AND UNDERSTAND THE ABOVE TERMS AND CONDITIONS AND WILL KEEP THIS DOG/CAT DESCRIBED HEREIN AS A FAMILY MEMBER. I/WE UNDERSTAND THAT THIS IS A BINDING CONTRACT ENFORCEABLE BY CIVIL LAW.
